**The Perquimans County Board of County Commissioners will hold a Public Hearing on Monday, June 4, 2012 at 6:35 PM** in the Commissioners' Meeting Room on the 1<sup>st</sup> floor of the Perquimans County Courthouse Annex Building located at 110 North Church Street, Hertford, NC, to consider the following requests:

- 1) Consideration of proposed Conditional Use Permit No. CUP-12-02, by Doris Dowridge, AAS, to operate "Anna's House of Learning," a Child Daycare (Home Occupation), at 787 Ocean Highway South (US Hwy 17), about one mile south of Edenton Road Street (SR 1125). Subject property zoned CH, Highway Commercial District and known as Tax Parcel No. 2-0060-0026.
- 2) Consideration of Application No. REZ-12-01, by Charles Newsome, to extend the existing CH Zone to include other portions of the property known as Tax Parcel No. 2-0068-0003, located at the southeast corner of Ocean Highway South (US Hwy. 17) and NC Hwy. 37, together with Tax Parcel No. 2-0068-0004 and the 196.98-foot segment of Mill Drive that divides the two Tax Parcels. Subject properties collectively contain about 6.56 acres and are currently zoned CH or RA-25 or RA.
