The North Carolina Department of Public Safety (NCDPS) anticipates annual funds in the above stated amount will be available for programs serving delinquent and at-risk youth beginning on or after July 1, 2025.

Local match rate for JCPC funds required: **10 %**.

As a result of the Risk and Needs Assessment data in the above-named county, programs that reduce risk, address the needs of juveniles, and increase protective factors will be considered for funding.

Proposed services should address the following concerns as reported in the Youth Assessment Screening Instrument (YASI):

- 67% had moderate risk; the state at 41%. Youth had moderate to high strengths.
- 11% high needs, the state at 6%; high moderate at 22% the state at 14%, 33% moderate, state 21%
- 44% had felony referrals to juvenile justice; the state at 35%.
- 11% were under the age of 12 at first referral; slightly above the state average at 9%.
- 22% had prior weapon offenses; the state at 17%
- 33% had family member(s) with prior criminal history; state at 26%.
- 11% consistently had inadequate parent/custodian supervision; the state at 2%.
- 44% police reports filed by the school; the state at 24%.
- 55% are failing some or most classes; state at 25%.
- 78% had one or more OSS events in the prior two years; state at 66%.
- 44% Had no interest in school activities; state at 31%
- 33% report no friends/no consistent friends; state at 15%
- 22% report some alcohol/substance use; state at 39%.
- 50% reported Under 12 at first use of alcohol/drugs; the state at 11.
- 11% have a physical abuse history; state at 9%.
- 22% reported bullying behavior; state at 10%.
- 11% demonstrated violent behavior using a weapon; the state at 8%
- 44% Demonstrated bullying/threatening behavior; the state at 23%
