ALBEMARLE REGIONAL HEALTH SERVICES PROVIDES UPDATE ON REGIONAL VACCINE CLINICS Updated COVID-19 vaccine counts, cases, and outbreaks.

Elizabeth City, NC – Albemarle Regional Health Services (ARHS) is providing updated information on COVID-19 vaccines, lab confirmed positive COVID-19 cases, and facility outbreaks as of 1 p.m. Friday, April 9, 2021 in addition to the weekly surveillance report (attached).

In addition to the Moderna vaccine, ARHS will now also be offering the Johnson & Johnson vaccine. This vaccine is one dose and is available to residents from the ARHS region who are 18 and over. Drive thru clinics for this vaccine will be held in Pasquotank, Perquimans, Currituck, and Hertford counties next week.

"We are excited to have both the Moderna and Johnson & Johnson vaccine available to all in our region," states R. Battle Betts, Jr., MPA, ARHS Health Director. "Being able to provide another vaccine to our community will help us continue to slow the spread of the virus and brings us one step closer to seeing our loved ones, traveling, and resuming normal activities."

ARHS is still accepting appointments for Moderna first dose vaccines at each of our local health departments. Appointments will be available to residents of the eight county region who are 18 and older. Please call your local health department to make an appointment to receive your first dose of vaccine. Please note, Johnson & Johnson will only be offered at targeted events and drive through clinics at this time. Appointments will be for Moderna vaccine only.

Both Moderna and Johnson & Johnson clinics are scheduled for next week. Please note locations and type of vaccine in the clinic schedule below. Individuals seeking a second dose of Moderna are eligible if they received their first dose of the Moderna vaccine on or before Thursday, March 18. You will need to bring the vaccine card you received with your first dose with you to these clinics. If you do not have your card, you may experience additional delays, or may be turned away and rescheduled because we have to verify your first dose for your safety.

Please do not arrive early at sites. You may be asked to leave by law enforcement.

If you received your first dose at one of our clinics, regardless of residence status, you will be able to receive your second dose as long as you have your vaccine card with you.

If you received your first dose of the COVID-19 vaccine with another provider such as Walgreens or CVS, you will need to return to that same facility for your second dose.

ARHS is reporting one death related to COVID-19 in a Pasquotank County resident. This individual was in the 50 - 64 year age range and succumbed to complications from the virus. This death is not related to any facility outbreaks, as there are no active outbreaks in the region at this time.

Although we are moving into the vaccine phase of the pandemic, COVID-19 testing is still available for those meeting criteria by appointment only at the local health departments across the region. ARHS encourages residents to call their primary care provider for an assessment or information on testing availability before calling the local health department. If someone does not have a primary care home, ARHS does offer primary care services. All tests will be completed through a curbside screening clinic at the local health department. For more information on criteria for COVID-19 testing or appointments, call 252-338-WELL/9355 or your local health department directly.

ARHS is collaborating with OptumServe to provide additional, no-cost COVID-19 testing sites in Bertie, Hertford, Gates, and Chowan counties. Typically testing is available Monday, Thursday, and Saturday from 10 a.m. to 2 p.m. and Tuesday and Friday from 1-5 p.m. You may check availability and register to make an appointment for testing by visiting https://lhi.care/covidtesting or by calling (877) - 562-4850.

ARHS is continuing to ask our community citizens to be mindful in practicing preventive and safety measures to prevent the spread of COVID-19. Please remember these precautions:

- Avoid close contact with people who are sick.
- Avoid touching your eyes, nose, and mouth.
- Stay home when you are sick.
- Cover your cough or sneeze with a tissue, then throw the tissue in the trash.
- Clean and disinfect frequently touched objects and surfaces using a regular household cleaning spray or wipe.
- Wash your hands often with soap and water for at least 20 seconds, especially after going to the bathroom; before eating; and after blowing your nose, coughing, or sneezing. If soap and water are not readily available, use an alcohol-based hand sanitizer with at least 60% alcohol. Always wash hands with soap and water if hands are visibly dirty.
- Practice social distancing; stay at least six feet away from others, avoid unnecessary travel, avoid handshakes, hugs and other close contact.
- Wear a cloth face covering in public.
