JOHNSON AND JOHNSON VACCINE CLINICS SCHEDULED FOR APRIL 14-16 2021 CANCELLED

Elizabeth City, NC –Albemarle Regional Health Services (ARHS) is cancelling the Johnson and Johnson vaccine clinics scheduled for April 14-16th in Currituck, Hertford, Pasquotank, and Perquimans counties. State and Federal guidance is recommending that sites pause the use of the Johnson and Johnson vaccine at this time. Out of an abundance of caution, ARHS will not be offering the Johnson and Johnson vaccine until we learn more information. It is our top priority to ensure the health and safety of our community citizens. We encourage individuals to move ahead with your vaccine plans by utilizing one of the other two vaccines that are available.

ARHS is still accepting appointments for Moderna first dose vaccines at each of our local health departments. Appointments will be available to residents of the eight county region who are 18 and older. Please call your local health department to make an appointment to receive your first dose of vaccine.

First and second dose Moderna vaccines are available at the clinics listed below. Individuals seeking a second dose of Moderna are eligible if they received their first dose of the Moderna vaccine on or before Thursday, March 18.
